Product

The apothecary consists of approximately 500 Chinese, Ayurvedic, and Western herbs and is in 3 formats.

- 5:1 Concentrated extract powder *not all herbs available in this format.
- Tincture (40-60% diluted grain alcohol in 1:5 ratio).
- Raw herb (whole, cut and sifted, and some powders) for teas, tangs and miscellaneous.

There is also the custom products services of both bulk or customer sizes made to your specifications.

Result:

- Greater flexibility for you
- Saves time and energy

Why tincture format is very effective

- 1) Increased client compliance
- 2) Ease of having on hand and taking the formula (due to the fast paced world we live in)
- 3) No preparation time like teas

Wholesale Rates

*5:1 concentrated extract powder, flat rate .35/g.

Tincture \$10/oz. available in 2 oz. and 4 oz. sizes.

Raw herb varies by herb, cost figured case by case.

Custom tea/tang (loose leaf) \$5/4 oz. bag.

Custom products bulk (i.e. 1 qt. oil or liniment), cost figured case by case.

Custom products, distribution size (i.e. 1, 2, 4 oz. salves are \$5, \$8, \$12 respectively), others cost figured case by case.

Those that might have an issue with the alcohol base can place the dosage of tincture in hot water and it will evaporate the alcohol and leave the essence of the formula.

Strength of each format in relation to each other starting with the most potent:

5:1 concentrated extract powder

Tincture 1:5 ratio

Teas or Tangs

Tea pills or pills (excellent tonics but no flexibility to custom formulate specifically to the client's needs)
